

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS
REGULAR BOARD MEETING HELD ON
TUESDAY, APRIL 26, 2011**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, April 26, 2011 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Patrick Call, Chair; Ann English, Vice-Chairman; Richard Searle, Supervisor; Michael Ortega, County Administrator; Britt Hanson, Chief Civil Deputy Attorney; and Katie Howard, Clerk of the Board.

Chairman Call called the meeting to order at 10:03 a.m.

Chairman Call announced that Item 9 would be removed from the agenda.

CONSENT

Motion by Vice-Chairman English to approve the Consent agenda, items 1-8 and 10-12; second by Supervisor Searle and approved 3-0.

Item 9: Supervisor Searle pointed out that the County was accepting a \$787.50 grant and the costs to administer would be higher than the amount of the grant. The Director of Prevention Services in the Health Department explained that the vouchers were actually for \$5.00 per individual, not the \$1.35 as stated. Based on this clarification, Supervisor Searle made a motion to approve item 9; second by Vice-Chairman English and approved 3-0.

PUBLIC HEARINGS

Board of Supervisors

13. Approve a person/location transfer liquor license application for a series #6 (bar) liquor license submitted by Mr. Wendell H. Gilbert III for Pizzeria Mimosa located at 4755 E. Neapolitan Way, Hereford, 85615.

Supervisor Searle made a motion to approve a person/location transfer liquor license application for a series #6 (bar) liquor license submitted by Mr. Wendell H. Gilbert III for Pizzeria Mimosa located at 4755 E. Neapolitan Way, Hereford, 85615.

Ms. Katie Howard, Clerk explained that reviewing departments recommended approval, the applicant has paid required fees and there are no known objections to this application.

Chairman Call opened the public hearing. No one wished to address the Board on this matter and he closed the public hearing and called for the vote.

The motion was approved, 3-0.

ACTION

Board of Supervisors

14. Adopt the Strategic Plan for Cochise County.

Mr. Ortega stated that the Strategic Plan has been brought to the Board a few times previously and this is the final draft. He explained that the process was budget-driven initially, beginning with a review of mandated and discretionary services, with the discovery that most services are mandated. The Strategic Plan incorporates the Vision

and Mission statements; seven strategic goals, with objectives, implementation strategies and measures for each.

Mr. Ortega then presented the 7 goals: “What” and “How” goals, and the structure of the plan components. He added that the goals and implementation strategies have been refined to include those that are most relevant, achievable and measurable.

He offered some observations about the process, saying that engagement has been critical—all elected officials and department directors participated, and employees through roundtables/soliciting feedback. He said the plan reinforces resource constraints, establishing the “new normal”. The idea is to encourage innovation and new ideas—instill a ‘no boundaries’ mentality.

He said he is very excited to see unlikely partners taking part in discussions around the table to develop new strategies and approaches. Roundtables with employees have been completed and changes from that process include a focus on emergency services/exercises. After the Board’s adoption, he said, we will integrate the plan with the 11-12 fiscal year budget. Administration will revisit the plan in one year and determine if all components are still relevant, refining measures at that time.

Vice-Chairman English commented that the process was very beneficial to all departments, both at the department director level and front line workers; discussion created more interaction/cooperation. It is important, she said, to recognize that this is a living document—this is a new process to hone the process that is introspective and measures our progress. She is extremely pleased that we have the beginnings of a plan.

Supervisor Searle said that going through the last several years’ budgets has been difficult without defined goals and he thinks this will help us. He appreciates the level of effort that went into this.

Chairman Call commended Mr. Ortega and Mr. Falkenberg on the work done to achieve this plan.

Mr. Ortega stated that he wanted to hone in on Searle’s comments regarding accountability (internal and to the public) and the desired change for County’s culture. He hopes to reference the Strategic Plan on a daily basis, to keep our focus on the goals. He said he had asked Mr. Falkenberg to take on assignment and he did so cheerfully and very professionally. He is proud to have him in the workforce.

Chairman Call called for the vote and the item was approved 3-0.

STATE & FEDERAL LEGISLATION

15. Discussion and possible action regarding the status of the Arizona state budget including discussion of the County Supervisors Association-produced document entitled "County Impacts in the Final Budget Plan", and legislative bills listed on the attached Legislative Policy Committee meeting agenda.

Mr. Ortega spoke about various bills in the legislature and the current status of each, including the prisoner credit bill which passed increasing inmate credit from \$10 per day

to \$50 per day. The Assessor's recordation fees, he said is currently scheduled to sunset the end of this calendar year; the extension did not pass the legislature. He added that there have been late-breaking changes on riders: Merit Rules under merit system used to provide employees with coverage under Merit Rules. With new language employees who are promoted or receive a salary adjustment will no longer be protected—will be 'at will' employees.

Mr. Ortega also reported that the budget document adopted by the legislature includes an inmate shift at a cost of \$1.0m (to Cochise County); the measure is to take effect June 2012.

REPORT BY MICHAEL J. ORTEGA, COUNTY ADMINISTRATOR -- RECENT AND PENDING COUNTY MATTERS

Mr. Ortega reported that he has a meeting tomorrow with the City of Sierra Vista regarding the possibility of a joint Communications Center. They will be reviewing opportunities to expand dispatch services.

CALL TO THE PUBLIC

Chairman Call opened the Call to the Public. Mr. Jack Cook addressed the Board on matters of personal concern. No one else wished to address the Board and the Call to the Public was closed.

SUMMARY OF CURRENT EVENTS

Report by District 1 Supervisor, Patrick Call – Reported that he attended a Water Resources Allocation Commission meeting two wks ago with a presentation of a report studying where water the is and where growth is in the future. The group formed a Water Recommendations Committee, and he was appointed Chairman. They will be making recommendations regarding how the state develops legislation and financing for large-scale rural water issues.

Report by District 3 Supervisor, Richard Searle – deferred report.

Chairman Call announced the special recognition event for veterans today at 3:00 p.m. There being no further business before the Board, he adjourned the meeting at 10:41 a.m.
