***PRESENTATION***

Motorcycle Safety and Driver Awareness presentation by Ms. Trina Meeks, owner, Ride Arizona Motorcycle Training Center, Casa Grande, Arizona.

Ms. Trina Meeks made a brief presentation about driver awareness and motorcycle safety. She particularly cautioned drivers to be aware of others who share the road and are less protected than those driving vehicles. She pointed out that most motorcycle/car crashes occur in intersections and advised drivers and riders alike to be especially cautious in those situations.

Ms. Meeks also stressed the importance for motorcyclists to obtain safety and skills training, practice their learned skills, be on the lookout at all times, and to wear appropriate safety gear. She commended the Board for recognizing the importance of these issues and affording her an opportunity to address them.
