TUESDAY, JANUARY 10, 2012**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, January 10, 2012 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Richard Searle, Chairman; Patrick Call, Vice-Chairman; Ann English, Supervisor; Michael Ortega, County Administrator; Jim Vlahovich, Deputy County Administrator, Britt Hanson, Chief Civil Deputy County Attorney; and Katie Howard, Clerk of the Board.

Mr. Ortega stated that in the future he will attach the County Supervisors Association (CSA) Legislative Policy Committee report.

There are four topics today:

1) He asked for feedback on HR 2043 and said the Board may want to consider coming out against this because it preempts local control. He discussed delays in bringing issues to the voters could be as long as 23 months.

Supervisor English asked why this was proposed and Mr. Ortega responded "potential cost-savings". He added that another possible complication would be length and complexity of ballots if all issues were saved for two years. The CSA has not suggested a position at this point; it came from the Arizona Association of Counties (AACo).

Chairman Searle commented that voter turnout is low on these consolidated election dates and that might be a concern.

2) SB 1031: This bill would establish proposed redistricting lines and provide guidance to those who want to run in 2012 and also regarding signatures collected prior to establishing boundaries.

3 and 4) Digital Arizona Highways Act: Provides permission within the state highway system and right-of-ways for digital infrastructure along state highways; it does not impact the County directly, but may increase pressure on local governments to do the same on county roads. It would also create an office of Digital Arizona Infrastructure Office.

Last issue is the Arizona State Retirement System (ASRS) change to realign the county/employee contributions to 50/50; it is currently at 53/47.

No action was taken on this agenda item.

Mr. Ortega has been working with staff on the move for Elections to Building A; also with Health and Housing staff. He said he will be bringing information and options to the Board in near future.
