

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS
REGULAR BOARD MEETING HELD ON
TUESDAY, MAY 8, 2012**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, May 8, 2012 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Richard Searle, Chairman; Patrick Call, Vice-Chairman; Ann English, Supervisor; Michael Ortega, County Administrator; Jim Vlahovich, Deputy County Administrator; Britt Hanson, Chief Civil Deputy County Attorney; and Arlethe Rios, Assistant to the Clerk of the Board.

Chairman Searle called the meeting to order at 10:00 a.m.

10. Approve the Arizona Department of Homeland Security Grant (77404-05) to Cochise County Sheriff's Office in the amount of \$59,800 to fill in the repeaters expansion project for the Northern area of the County (Cascabel) for the grant period of April 1, 2012 through March 31, 2013.

Vice-Chairman Call made a motion to approve items 1-6 and 8-10 of the Consent Agenda. Supervisor English seconded the motion and it carried unanimously.

Chairman Searle removed item 7 from the consent agenda due to conflict of interest.

ACTION

Board of Supervisors

11. Approve over-the-counter sales of tax deed properties remaining unsold following the March 1, 2012 tax deed land auction and subsequent over-the-counter sales, as set forth in the attached Exhibit A, plus related administrative fees.

Supervisor English made a motion to approve over-the-counter sales of tax deed properties remaining unsold following the March 1, 2012 tax deed land auction and subsequent over-the-counter sales, as set forth in the attached Exhibit A, plus related administrative fees.

Chairman Searle asked if there were any additional bids and there were none.

Chairman Searle called for the vote and it carried 3-0.

12. Discussion and possible direction from the Board regarding potential ban on fireworks and open fires in unincorporated areas of the County.

Mr. Ortega gave the background on "open fires" and the reason why many think a ban should be in place, mostly due to last year's fires in Cochise County.

The Board discussed current regulations and laws in place to obtain burning permits and consequences for those who do not abide by them.

Chairman Searle stated that citizens currently have to obtain permits directly from the Arizona Department of Environmental Quality (ADEQ).

Supervisor English thought that the county should raise awareness on the danger of "open fires".

Lieutenant Mark Genz, Sheriff's Office stated that there are laws to hold people accountable for fires under the Arizona Revised Statutes, but there has to be evidence in order to press charges.

Mr. Hanson defined the difference between approving an ordinance regarding "open fires" and declaring a state of emergency. He stated that he will work with Mr. Mike Evans, Emergency Services Director, and put a draft together for the Board to review.

Community Development

13. [ITEM TABLED FROM APRIL 10, 2012 MEETING]: Adopt Resolution 12-11 to abandon the Bachmann Springs Phase One Final Subdivision Plat, the Assurance Agreement, and the Final Plan.

Vice-Chairman Call made a motion to remove this item from the table. Supervisor English seconded the motion and it carried unanimously.

Ms. Beverly Wilson, Senior Planner, presented the item using a PowerPoint presentation (available on the County's website). Ms. Wilson reviewed the history of the subdivision, which was approved in 2007 and revoked in 2010. She stated that staff was recommending approval of the resolution to abandon the final plat, assurances, and final plat.

Mr. Hanson reviewed the last action by the attorney of Bachman Springs, which was to ask for an extension, but an extension was never received from the attorney.

Mr. Rick Carey, First TD Bank, represented the financial investors for this subdivision. He stated that he had been in contact with Mr. Bachmann and found out that the attorney was attending today's meeting. He then asked the Board for another extension.

Supervisor English said that the County had allowed plenty of time and it appeared as though the subdivision had already been abandoned.

Supervisor English made a motion to adopt Resolution 12-11 to abandon the Bachmann Springs Phase One Final Subdivision Plat, the Assurance Agreement, and the Final Plan. Vice-Chairman Call seconded the motion.

Mr. Rick Carey expressed his concern for the taxes pending on the parcels.

Mr. Hanson responded to Mr. Carey's question by letting him know that the Treasurer's Office would refund the liens with interest.

Supervisor English expressed her concern for those citizens who bought tax liens on some of the parcels in this subdivision and their ability to finish their lien process.

Chairman Searle called for the vote and it carried 3-0.

County Sheriff

14. Approve the nominal use of county resources for the Sheriff's Office to conduct a Teen Driver Program in county schools through Fiscal Year 2013.

Lieutenant Mark Dannels, Sheriff's Office, presented this item. Lt. Dannels stated that the program has always been great. He gave a brief background and listed the benefits of the program and said that the Sheriff's Office was recommending approval and support for this program.

Vice-Chairman Call made a motion to approve the nominal use of county resources for the Sheriff's Office to conduct a Teen Driver Program in county schools through Fiscal Year 2013. Supervisor English seconded the motion.

Chairman Searle called for the vote and it carried 3-0.

Court Administration

15. Adopt Resolution 12-13 modifying Section 5.2 of Exhibit 1 to Resolution 08-24, which modifies the Judicial Administrative Fee Schedule, to revise the procedures for approval and use of the Justice Court Enhancement Fund.

Mr. Michael Ortega, County Administrator, presented this item. Mr. Ortega described the changes to the fee schedule and stated the revisions were based on the criteria set by the Board.

Supervisor English pointed out erroneous wording on the resolution. Mr. Hanson stated that it had been left there in error and would be corrected before being signed and recorded.

Chairman Searle asked if the Courts were in agreement and Mr. Ortega replied that they had been consulted and approved the modification.

Supervisor English made a motion to adopt Resolution 12-13 modifying as discussed, which modifies the Judicial Administrative Fee Schedule, to revise the procedures for approval and use of the Justice Court Enhancement Fund. Vice-Chairman Call seconded the motion.

Chairman Searle called for the vote and it carried 3-0.

Health & Social Services

16. Approve IGA number ADHS 12-020641 between the Arizona Department of Health Services and Cochise Health and Social Services in the amount of \$45,000 for the term 4/16/12 through 4/30/13.

Ms. Mary Gomez, Health & Social Services Director, presented this item. Ms. Gomez said the grant was given by the State to encourage County health departments to become accredited. She stated that the accreditation would be very similar to the accreditations held by medical facilities nationwide. The grant will help the County comply with the first standard of the accreditation. She clarified that acceptance of the grant did not commit the County, but would help the organization get a preference point for other grants.

Vice-Chairman Call made a motion to approve IGA number ADHS 12-020641 between the Arizona Department of Health Services and Cochise Health and Social Services in the amount of \$45,000 for the term 4/16/12 through 4/30/13. Supervisor English seconded the motion.

Chairman Searle called for the vote and it carried 3-0.

STATE & FEDERAL LEGISLATION

Discussion and possible action regarding state and federal legislative matters, including but not limited to the items in the attached County Supervisors Association Legislative Policy Committee Agenda and the proposed State budget.

Supervisor English stated that the legislative session was coming to a close and there was very little left to discuss. She said the prisoner shift bill did not pass and the County would save money.

Mr. Ortega pointed out that projections for the coming year were almost done and that the County would have to reimburse employees for the raise of health insurance last year, which would come out to \$180,000. He stated that although the County Supervisors Association brought the item up, no other counties were interested in fighting the State's decision.

No action was taken on this agenda item.

REPORT BY MICHAEL J. ORTEGA, COUNTY ADMINISTRATOR -- RECENT AND PENDING COUNTY MATTERS

Mr. Ortega reported that budget work sessions would begin in the coming weeks and asked the Board to submit projects for consideration. He said the Douglas Regional Service Center move was going smoothly and the ribbon cutting ceremony would be early in June. He stated that he would also be attending the County Supervisors Association Managers meeting on Friday.
