

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS  
REGULAR BOARD MEETING HELD ON  
TUESDAY, JUNE 12, 2012**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, June 12, 2012 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Richard Searle, Chairman; Patrick Call, Vice-Chairman; Ann English, Supervisor; Michael Ortega, County Administrator; Jim Vlahovich, Deputy County Administrator; Dave Fifer, Civil Deputy County Attorney; and Katie Howard, Clerk of the Board.

Chairman Searle called the meeting to order at 10:04 a.m.

**Board of Supervisors**

1. Approve the Minutes of the regular meeting of the Board of Supervisors of May 22, 2012
2. Approve renewal of contract between the Board of Supervisors and County Administrator, effective July 1, 2012, in accordance with the terms as set forth in the attached Exhibit.

### **County Sheriff**

22. Approve City of Tucson High Intensity Drug Trafficking Area (HIDTA) Grant Agreement HT-12-2230 with a term of January 1, 2012 to December 31, 2013 providing a total of \$109,659 in salary, employee related expenses, overtime, vehicle expenses and equipment to assign one deputy sheriff to the Southeastern Arizona Major Investigative Team (SAMIT), a U.S. Drug Enforcement Administration drug enforcement task force.

Commander Marc Denney, Sheriff's Office presented this item. Commander Denney requested that the Board approve the HIDTA Grant through December 31, 2013 and explained that this was an annual renewal grant. He responded to questions regarding the use of the funds, adding that it is a full-time deputy position.

Vice-Chairman Call made a motion to approve City of Tucson High Intensity Drug Trafficking Area (HIDTA) Grant Agreement HT-12-2230 with a term of January 1, 2012 to December 31, 2013 providing a total of \$109,659 in salary, employee related expenses, overtime, vehicle expenses and equipment to assign one deputy sheriff to the Southeastern Arizona Major Investigative Team (SAMIT), a U.S. Drug Enforcement Administration drug enforcement task force. ### **Elections & Special Districts**

23. Adopt Resolution 12-18 naming the polling locations for the voting precincts for the Primary Election to be held on August 28, 2012 and the General Election to be held on November 6, 2012.

Ms. Juanita Simmons, Elections Director presented this item. Ms. Simmons explained that the Board approved the reduction of the number of precincts from 64 to 49, through the redistricting process and she is now requesting the approval of the 49 polling locations within those precincts. She reviewed the four changes in polling locations and the reasons for them and requested the Board's approval.

Supervisor English made a motion to adopt Resolution 12-18 naming the polling locations for the voting precincts for the Primary Election to be held on August 28, 2012 and the General Election to be held on November 6, 2012. Vice-Chairman Call seconded the motion.

Chairman Searle called for the vote and it carried 3-0.

### **Fleet**

24. Approve the award of Invitation for Bids (IFB) No. 12-22-HFM-04 for Bulk Fuel (diesel & unleaded) to Union Distributing in the estimated amount of \$2,680,879 for the period of June 12, 2012 through June 11, 2013 for the Heavy & Light Fleet Management Departments.

Mr. Dave Seward, Procurement Director presented this item. Mr. Seward explained that this is the annual approval for bulk fuel, adding that the vendors this year were requested to install tech monitors to better enable the County to keep track of its fuel usage. He responded to a question from the Board regarding pricing.

Vice-Chairman Call made a motion to the award of Invitation for Bids (IFB) No. 12-22-HFM-04 for Bulk Fuel (diesel & unleaded) to Union Distributing in the estimated amount of \$2,680,879 for the period of June 12, 2012 through June 11, 2013 for the Heavy & Light Fleet Management Departments. Supervisor English seconded the motion.

Chairman Searle called for the vote and it carried 3-0.

### **REPORT BY MICHAEL J. ORTEGA, COUNTY ADMINISTRATOR -- RECENT AND PENDING COUNTY MATTERS**

Mr. Ortega reported that he would be attending an Equal Employment Opportunity Commission (EEOC) hearing in Phoenix tomorrow and an Arizona Counties Insurance Pool (ACIP) Board meeting. On Thursday there will be a Budget Work Session that will provide an opportunity for the Clerk of the Court to present her budget requests to the Board. Mr. Ortega said he will also do a follow up and answer questions the Board presented earlier and ask the Board for a general direction on the budget as a whole. Finally he will also attend the County Supervisors Association (CSA) County Managers session on Friday regarding the legislative platform for next year.
