AMENDMENT FIVE

The Agreement entered into between the Cochise County Board of Supervisors, for and on behalf of the Cochise County Sheriff's Office, hereinafter referred to as the County, and the Director of the Arizona Department of Corrections, for and on behalf of its Correctional Officer Training Academy (COTA), hereinafter known as the Department is hereby amended as follows:

Purpose of Amendment: To revise the cost for each candidate as stated below.

Section 2, Paragraph 2.4 change:

From: The cost for each candidate per seven (7) week course to the County shall be \$660.00, not to exceed \$850.00 through the term of this Agreement.

To: The cost for each candidate per seven (7) week course {seven (7) week academy with additional on-line training for an equivalent of a 9 week training} to the County shall be \$660.00, not to exceed **\$800.00** through the term of this Agreement.

All other terms and conditions of this Contract shall remain in full force and effect.
