

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS  
REGULAR BOARD MEETING HELD ON  
TUESDAY, SEPTEMBER 25, 2012**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, September 25, 2012 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Richard Searle, Chairman; Patrick Call, Vice-Chairman; Ann English, Supervisor; Michael Ortega, County Administrator; Jim Vlahovich, Deputy County Administrator; Britt Hanson, Chief Civil Deputy County Attorney; and Katie Howard, Clerk of the Board.

Chairman Searle called the meeting to order at 10:21 a.m.

**Board of Supervisors**

1. Approve publication of the Governor's Proclamation calling for the General Election on Tuesday, November 6, 2012.
2. Approve the Minutes of the regular meetings of the Board of Supervisors of August 28, 2012 and September 11, 2012.

**Health**

4. Approve Amendment #3 to IGA # ADHS12-007884, Emergency Preparedness Program, between the Arizona Department of Health Services and Cochise Health & Social Services, in the amount of \$213,083, for the period of July 1, 2012 through June 30, 2013.

#### **Information Technologies**

5. Approve Antelope Pass site sharing agreement between Cochise County and the US Forest Service to locate a repeater on the U.S. Forest Service tower.

6. Approve two Memorandums of Understanding between Cochise County and the Arizona Department of Public Safety to assume the tower site leases for communications towers located on Mule Mountain (DPS 2012-157) and Texas Canyon (DPS 2012-158).

#### **Juvenile Probation**

7. Approve application for and receipt of funding as awarded by the State of Arizona Governor's Office for Children, Youth and Families (GOCYF) to Cochise County and administered by Juvenile Court Services for purpose of operating the Juvenile Drug Court.

Vice-Chairman Call made a motion to approve items 1-7 of the Consent Agenda. Supervisor English seconded the motion and it carried unanimously.

### **ACTION**

#### **Health**

8. Approve the new IGA #YH13-0002, Enrollment Suspension of AHCCCS Eligibility for Jail Inmates, between the Arizona Healthcare Cost Containment System (AHCCCS) and Cochise County, for the period from 10/1/12 to 9/30/17; however, the agreement may be terminated by either party with thirty days written notice.

Mr. Ray Falkenberg, Administrative Services Manager, Health & Social Services presented this item. Mr. Falkenberg explained to the Board that jail inmates are no longer eligible for AHCCCS when they are admitted to jail; this IGA allows suspension of AHCCCS rather than outright cancellation of coverage that results in County savings and benefits both the County and its residents.

Supervisor English made a motion to approve the new IGA #YH13-0002, Enrollment Suspension of AHCCCS Eligibility for Jail Inmates, between the Arizona Healthcare Cost Containment System (AHCCCS) and Cochise County, for the period from 10/1/12 to 9/30/17; however, the agreement may be terminated by either party with thirty days written notice. Vice-Chairman Call seconded the motion.

Chairman Searle called for the vote and it carried 3-0.

#### **Heavy Fleet**

9. Approve the purchase of Heavy Equipment from Empire Machinery consisting of two Motor Graders, One Wheel Loader, three Broce Broom Machines, and one used Compactor in the amount of \$836,338.89 for the Heavy Fleet Management Department.

Mr. Dave Seward, Procurement Director presented this item. Mr. Seward explained that this equipment is available under a contract with City of Tucson, priced competitively and is compatible with existing heavy fleet inventory.

Mr. Ortega said the County is not leasing any of the equipment and we will look at each opportunity for rates to make a conscious decision each time. There are adequate reserves in our equipment replacement funds and we are not financing equipment at this time.

Chairman Searle stated that he is having difficulty with the policy of moving equipment at the end of the warranty period of 7 years or 6000 hours; with Light Fleet we are taking vehicles past the warranty period. He is concerned with how we are using and maintaining equipment.

Mr. Ruben Miranda, Fleet Director explained that there are no available loaders for loan in the event that equipment breaks down, unlike with Light Fleet, and we are extending the use of the equipment for Heavy Fleet. He provided details regarding costs for maintenance and repairs versus purchasing new equipment.

There was a discussion among the Board members and Mr. Ortega offered to bring this item back to the Board in a Work Session format to discuss the philosophy and accommodate any policy changes.

Vice-Chairman Call made a motion to approve the purchase of Heavy Equipment from Empire Machinery consisting of two Motor Graders, One Wheel Loader, three Broce Broom Machines, and one used Compactor in the amount of \$836,338.89 for the Heavy Fleet Management Department. Supervisor English seconded the motion.

Chairman Searle asked if Empire put a new warranty on when they resell the used equipment and Mr. Miranda explained that Empire refurbishes the equipment and does put them under warranty at resale.

Chairman Searle called for the vote and it carried 2-1 (Searle opposed).

10. Approve the purchase of an Aljon 2012 Advantage 500 Landfill Compactor to Aljon Mfg. in the amount of \$653,027 plus applicable tax for the Heavy Fleet Management Department.

Mr. Dave Seward, Procurement Director presented this item. Mr. Seward explained that this was a replacement for the compactor which has been in use for 11 years, which has over 17,000 hours on it and said the old machine will be kept as a backup.

Supervisor English made a motion to approve the purchase of an Aljon 2012 Advantage 500 Landfill Compactor to Aljon Mfg. in the amount of \$653,027 plus applicable tax for the Heavy Fleet Management Department. Vice-Chairman Call seconded the motion.

Vice-Chairman Call asked regarding ramifications on the Solid Waste Management budget.

Mr. Ortega explained that there are enough dollars in the Equipment Replacement fund to cover this purchase. There will be an IOU in the Solid Waste fund to the Highways Heavy Equipment fund which will be repaid over time. The equipment replacement fund has been in place since the inception of the Solid Waste Management program.

Chairman Searle called for the vote and it carried 3-0.

## ***PUBLIC HEARINGS***

### **Community Development**

11. Adopt Zoning Ordinance 12-13, conditionally approving Docket Z-12-06, a request to rezone 12 acres from RU-4 to Light Industry, pursuant to the application of Alan Seitz.

Mr. Mike Turisk, Planning Division Manager, presented this item using a PowerPoint presentation. Mr. Turisk reviewed the applicant's request to rezone 12 acres from RU-4 to Light Industry. The property has a 60,000 square foot building on the property. He showed a location map and a zoomed in graphic showing the three parcels and red shading designating areas of the Community Plan that are appropriate for Light Industry use. He reviewed the proposed setback modification; if Board does not approve, applicant will have to apply for a variance. The department has received one letter of support and one letter of protest, within the 1500' notification radius. Mr. Turisk reviewed the factors in favor of approval and those against. On September 12, 2012, the Planning and Zoning Commission voted unanimously to approve and staff is recommending conditional approval; he reviewed the standard condition.

Chairman Searle opened the public hearing. No one wished to address the Board and Chairman Searle closed the public hearing.

Vice-Chairman Call made a motion to adopt Zoning Ordinance 12-13, conditionally approving Docket Z-12-06, a request to rezone 12 acres from RU-4 to Light Industry, pursuant to the application of Alan Seitz. Supervisor English seconded the motion.

Chairman Searle called for the vote and it carried 3-0.

Mr. Ortega stated that the Cochise County Fair starts this Thursday and the County will have a presence there; also the County is hosting the annual County Supervisors Association Legislative Summit next week in Sierra Vista. He also said Sheriff Dever's Memorial Service is Wednesday evening.
