IN THE MATTER OF THE APPLICATION for approval of the assignment of a Telecommunications Franchise to use public streets, roads and alleys;

NOTICE IS HEREBY GIVEN, that the Board of Supervisors of Cochise County, Arizona, has been requested to approve the assignment of a telecommunications franchise to use the public roads, streets, alleys and highways within the following described area, to-wit: Area situated in the following Township/Ranges of the Gila and Salt River Base and Meridian, Cochise County, Arizona; In T18S R24E: The south half of Sections 11 & 12 and all of Sections 13, 14, 23 thru 26, 35 & 36; In T18S R25E: The south half of Sections 7 thru 12 and all of Sections 13 thru 36; In T18S R26E: The south half of Sections 10 & 11, the west half of Section 23 and all of Sections 7 thru 9 and 14 thru 35; in T19S R23E: All of Sections 1 thru 8, 22 thru 27 and 34 thru 36; All of T19S R24E, T19S R25E and T19S R26E; In T19S R27E: All of Sections 4 thru 9, 16 thru 21 and 28 thru 33; In T20S R23E: The east half of section 3 and all of Sections 1, 2, 10 thru 15, 22 thru 27 and 34 thru 36; All of T20S R24E, T20S R25E and T20S R26E; In T20S R27E: All of sections 3 thru 10, 15 thru 22 and 27 thru 34; In T21S R23E: All of sections 1, 2, 11 thru 14 and 23 & 24; In T21S R24E: All of sections 1 thru 24; In T21S R25E: All of sections 1 thru 27 and 35 & 36; All of T21S R26E; In T21S R27E: All of sections 2 thru 11, 14 thru 23 and 26 thru 35; In T22S R25E: The north half and the southeast quarter of section 13 and all of sections 1, 2, 11, 12 and 14; In T22S R26E: The north half of sections 13 thru 18 and all of sections 1 thru 12; In T22S R27E: The north half of sections 13 thru 18 and all of sections 1 thru 12

Prior to the consideration of this request, the Cochise County Board of Supervisors shall hold a public hearing on July 23, 2013 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona at which the applicant, Copper Valley Telephone, Inc. and its proposal shall be examined and the public and all interested parties shall be afforded a reasonable opportunity to be heard.
