

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS  
REGULAR BOARD MEETING HELD ON  
TUESDAY, AUGUST 27, 2013**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, August 27, 2013 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Ann English, Chairman; Richard Searle, Vice-Chairman; Patrick Call, Supervisor; Michael Ortega, County Administrator, Jim Vlahovich, Deputy County Administrator; Britt Hanson, Chief Civil Deputy County Attorney; and Kim Lemons, Assistant to the Clerk of the Board.

Chairman English called the meeting to order at 10:00 a.m.

**PLEDGE OF ALLEGIENCE**

**ROLL CALL** – All three supervisors present.

**CALL TO THE PUBLIC**

Chairman English opened the Call to the Public.

Mr. Jackson discussed the removal of the Planning and Zoning Commission Chairman Lynch for cause and cited statutes.

Mr. Jack Cook addressed the Board on matters of personal concern.

No one else chose to speak and Chairman English closed the Call to the Public.

**CONSENT**

**Board of Supervisors**

1. Approve revisions to the Cochise County Toilet Rebate Program regarding certain restrictions to Cochise County applicants within the Sierra Vista Sub-watershed of the San Pedro River; and add eligibility requirements for 501(c)3 non-profit water conservation organizations.
2. Approve appointment of Arlethe G. Rios as Clerk of the Board of Supervisors effective September 3, 2013.
3. Approve the Minutes of the regular meeting of the Board of Supervisors of August 13, 2013.

**Finance**

4. Approve demands and budget amendments for operating transfers.

Warrants Nos.72150-72333, 72355-72374, 72379-72517 were issued in the amount of \$1,331,116.37.

Pursuant to A.R.S. §11-217(C), the published minutes shall include all demands and warrants approved by the Board in excess of one thousand dollars except that multiple demands and warrants from a single supplier or individual under one thousand dollars whose cumulative total exceeds one thousand dollars in a single reporting period shall also be published.

Issued warrants are listed as an attachment at the end of the minutes.

Vice-Chairman Searle made a motion to approve items 1-4 of the Consent Agenda with a correction to Item 2, changing the effective date to September 1, 2013. Supervisor Call seconded the motion and it carried unanimously.

**ACTION**

### **Community Development**

5. Approve a Substitute Assurance Agreement for the Walnut Valley Ranch Subdivision with Pioneer Title Agency as trustee under trust number 321705, and extending the deadline to complete improvements to August 27, 2016.

Ms. Beverly Wilson, Planning Director, presented this item using a PowerPoint presentation. Ms. Wilson gave the subdivision location, and stated it is a minor expedited subdivision with one plat. She reviewed the conditions of sale when 23 lots were approved in 2006. In February of 2010 a trustee deed was recorded as a result of foreclosure. Pioneer Title released the original Assurance Agreement, which is a contract between the County and developer to assure improvements are made to the lots prior to sale. The new owners have submitted this Substitute Assurance Agreement for consideration and staff is recommending approval.

Supervisor Call made a motion to approve a Substitute Assurance Agreement for the Walnut Valley Ranch Subdivision with Pioneer Title Agency as trustee under trust number 321705, and extending the deadline to complete improvements to August 27, 2016. Vice-Chairman Searle seconded the motion.

Vice-Chairman Searle said this issue was covered in an earlier Work Session; it makes sense to get assurance back in place but may not want to extend past 2016.

Chairman English agreed that the message to developers is that each extension will be looked at but an automatic continuation will not always be the result. Supervisor Call concurred.

Chairman English called for the vote and it carried 3-0.

### **County Treasurer**

6. Adopt Resolution 13-29 authorizing Cochise County Treasurer to collect and disburse the property taxes for 2013 pursuant to A.R.S. 42-18003.

Vice-Chairman Searle moved to adopt Resolution 13-29 authorizing Cochise County Treasurer to collect and disburse the property taxes for 2013 pursuant to A.R.S. 42-18003. Supervisor Call seconded the motion.

The Board noted that this item should have been on the consent agenda.

Chairman English called for the vote and it carried 3-0.

### **Solid Waste**

7. Approve the award of Request for Proposals (RFP) No. 13-50-SWD-04 to hire a Consultant to perform a Solid Waste Operational Efficiency and Cost of Service Analysis to Civil & Environmental Consultants, Inc. in the not to exceed dollar amount of \$48,650.

Mr. Dave Seward, Procurement Director, presented this item. Mr. Seward said Procurement had received two proposals and the evaluation committee ranked Civil & Environmental Consults, Inc. as the number one firm to provide these services.

Mr. Ortega said this is an analysis of the entire system to validate efficiencies and costs to operate the landfill and all of the transfer stations. The goal is for this analysis to give us expertise in the operation of the landfill, and transfer stations and result in recommended price adjustments if necessary.

Supervisor Call asked if this was suggested by the Rate, Review and Advisory Board (RRAB) and Mr. Ortega concurred but noted that the RRAB did not review the applications because a quorum for them to meet was not met.

Mr. Seward said the consultants were out of Phoenix.

The Board talked about cost-efficiencies already put in place by Mr. Haverty and said this is the next step in fine tuning the process.

Supervisor Call moved to approve the award of Request for Proposals (RFP) No. 13-50-SWD-04 to hire a Consultant to perform a Solid Waste Operational Efficiency and Cost of Service Analysis to Civil & Environmental Consultants, Inc. in the not to exceed dollar amount of \$48,650. Vice-Chairman Searle seconded the motion.

Chairman English called for the vote and it carried 3-0.
