

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS
REGULAR BOARD MEETING HELD ON
TUESDAY, SEPTEMBER 10, 2013**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, September 10, 2013 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Ann English, Chairman; Richard Searle, Vice-Chairman; Patrick Call, Supervisor; Michael Ortega, County Administrator, Jim Vlahovich, Deputy County Administrator; Britt Hanson, Chief Civil Deputy County Attorney; and Arlethe Rios, Clerk of the Board.

Chairman English called the meeting to order at 10:00 a.m.

PLEDGE OF ALLEGIENCE

CALL TO THE PUBLIC

Chairman English opened the Call to the Public.

Mr. Jack Cook addressed the Board on matters of personal concern.

No one else chose to speak and Chairman English closed the Call to the Public.

1. Approve the Minutes of the regular meeting of the Board of Supervisors of August 27, 2013.
2. Approve the U.S. Fish and Wildlife Service Memorandum of Understanding for Cooperating Agencies and the Coordination Process for Mexican Wolf Environmental Impact Statement.
3. Approve a Proclamation declaring September 22-28, 2013 as Employer Support of the Guard and Reserve week.
4. Appoint Ms. Geraldine Alexis as a Cochise County Democratic Committee Precinct Committee Member in Precinct #42 SV Vista Village, to begin serving immediately.

5. Approve the Victims' Rights Program (VRP) Award Agreement, A.G. #:2014-002, in the amount of \$32,300 between the Arizona Attorney General and the Cochise County Attorney's Office, for the period July 1, 2013 to June 30, 2014.
6. Approve the proposed settlement of the Tax Appeal in David Snowdon and Jessica Snowdon v. Cochise County, TX2013-000044 (Assessor parcel No. 109-10-010D), now pending in Arizona Tax Court, a division of the Superior Court of and for Maricopa County.

9. Approve Grant Offer and Agreement #3-04-0013-008-2013 from the Federal Aviation Administration for the Master Plan Update Study at the Bisbee Douglas International Airport in the amount of \$196,407 and provide matching funds of 4.47% in the additional amount of \$9,641.

Juvenile Probation

11. Approve the Memorandum Of Understanding (MOU) between Cochise County Juvenile Court Services and Educational Options Foundation (Ed Options) for program equipment for online education from September 1, 2013 through June 30, 2014.

Workforce Development

12. Approve Amendment #12 to Title IB Adult, Youth, and Dislocated Worker contract DE111004001 between Cochise County and the Arizona Department of Economic Security for the Workforce Investment Act (WIA) Service Delivery Area from July 1, 2013 to December 31, 2014.

Vice-Chairman Searle made a motion to approve items 1-12 of the Consent Agenda. Supervisor Call seconded the motion and it carried unanimously.

ACTION

Emergency Services

13. Approve the award of Professional Services Agreement (PSA) No. 14-08-BOS-04 to hire Logan Simpson Design, Inc. to develop a Cochise Countywide Community Wildfire Protection Plan in the amount of \$39,620.

Mr. Norm Sturm, Emergency Services Coordinator, presented this item. Mr. Sturm gave background information. He said that the County had considered input from the community and that the other half of the cost was funded from the State Forrest Service.

Supervisor Call made a motion to approve the award of Professional Services Agreement (PSA) No. 14-08-BOS-04 in the amount of \$39,620 to hire Logan Simpson Design, Inc. to develop a Cochise Countywide Community Wildfire Protection Plan. Vice-Chairman Searle seconded the motion.

Chairman English called for the vote and it carried 3-0.

14. Approve Grant Agreement No. SFA 11-304 with the Arizona State Forestry Division in the amount of up to \$10,500 with a cash match of up to \$10,500 for the development of a Countywide Community Wildfire Protection Plan.

Ms. Lisa Marra, Grants Administrator presented this item. Ms. Marra gave the background information and stated that staff recommended approval of this grant.

Vice-Chairman Searle moved to approve Grant Agreement No. SFA 11-304 with the Arizona State Forestry Division in the amount of up to \$10,500 with a cash match of up to \$10,500 for the development of a Countywide Community Wildfire Protection Plan. Supervisor Call seconded the motion.

Chairman English called for the vote and it carried 3-0.

15. Approve cost proposals for Airport Master Plan Updates for Cochise County Airport (CC) and Bisbee Douglas International Airport (BDI) in the amounts of \$188,106 and \$208,028 respectively to Armstrong Consultants, Inc.

Mr. Dave Seward, Procurement Director, presented this item. Mr. Seward said that the funds used were coming from federal grants with a County match and that staff recommended approval.

Supervisor Call asked about the amount the County was contributing.

Ms. Marra said the total would be an estimate of \$20,000 for both the Willcox Airport and the Douglas Airport.

Supervisor Call made a motion to approve cost proposals for Airport Master Plan Updates for Cochise County Airport (CC) and Bisbee Douglas International Airport (BDI) in the amounts of \$188,106 and \$208,028 respectively to Armstrong Consultants, Inc. Vice-Chairman Searle seconded the motion.

Chairman English called for the vote and it carried 3-0.

Board of Supervisors

16. Approve an Intergovernmental Agreement (IGA) with the City of Douglas for reimbursement of the local match outlined in the Intergovernmental Agreement with AHCCCS for Supplemental Payments to Disproportionate Share Hospitals and Safety Net Care Pool to benefit Southeast Arizona Medical Center in an amount of up to \$480,366.03 over a period of six fiscal years.

Mr. Britt Hanson, Chief Civil Deputy Attorney and Mr. Mike Ortega, County Administrator presented this item. Mr. Ortega said this agreement had been discussed in the past and that there were some changes made so it had to be brought back to the Board for approval. He noted that the main change was extending the payback period for the City of Douglas. He stated that funds would be disbursed when the County received notice from the City of Douglas.

Chairman English explained that this agreement was to help Southeastern Arizona Medical Center get federal financial aid to keep hospital financially stable. She noted that this was a way to help the hospital without using taxpayer monies.

Vice-Chairman Searle moved to approve an Intergovernmental Agreement (IGA) with the City of Douglas for reimbursement of the local match outlined in the Intergovernmental Agreement with AHCCCS for Supplemental Payments to Disproportionate Share Hospitals and Safety Net Care Pool to benefit Southeast Arizona Medical Center in an amount of up to \$480,366.03 over a period of six fiscal years. Supervisor Call seconded the motion.

Chairman English called for the vote and it carried 3-0.

PUBLIC HEARING

Board of Supervisors

17. Hold public meeting and record comments for input into Cochise County's official comments on the Proposed Revision to the Nonessential Experimental Population of the Mexican Wolf and give staff direction.

Chairman English explained the process to the audience and opened the public hearing.

Ms. Kim Mulhern, Consultant, presented this item using a PowerPoint presentation. Ms. Mulhern gave the background and discussed what U.S. Fish and Wildlife was proposing. She said she had worked with Mary Darling, biologist and consultant to get the information together. She listed important dates in the process of submitting comments and noted that Sheri Barrette, U.S. Fish and Wildlife representative, would be available for comments.

Ms. Darling explained the release of the wolf in Mexico and how it impacts citizens in the County.

Ms. Barrette said that the proposal was to release the Mexican Wolf into more areas without causing major impacts to humans and other animals. She stated that wolves would not be released in Cochise County, but the border of the wolf population would be extended all the way to the Mexican border. She noted that the only difference with the

experimental area would be consequences for lethal control. She said that this was only one of the options that was being researched and that comments and concerns would be taken into consideration. Ms. Berrett stated that the program had a 50% success rate, the majority of the public favored wolf recovery, and that the main purpose of her agency was to recover endangered species.

Chairman English excused herself to attend George Warren sculpture presentation and handed Chairmanship to Vice-Chairman Searle.

Supervisor Call seconded the motion.

The Board thanked everyone for participating in the discussion.
