

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS
REGULAR BOARD MEETING HELD ON
TUESDAY, NOVEMBER 19, 2013**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, November 5, 2013 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Ann English, Chairman; Richard Searle, Vice-Chairman; Patrick Call, Supervisor; Mike Ortega, County Administrator; Jim Vlahovich, Deputy County Administrator, Britt Hanson, Chief Civil Deputy County Attorney; and Arlethe Rios, Clerk of the Board.

Chairman English called the meeting to order at 10:00 a.m.

PLEDGE OF ALLEGIENCE

ROLL CALL – All three supervisors present.

CALL TO THE PUBLIC

Chairman English opened the Call to the Public.

No one chose to speak and Chairman English closed the Call to the Public.

CONSENT

Board of Supervisors

1. Adopt Resolution 13-39 requesting the Arizona Legislature restore local Highway User Revenue Funds (HURF) and work with transportation stakeholders to identify and enact revenue enhancements for the existing HURF distribution system and to pursue policies that improve efficient utilization of transportation resources.
2. Approve the Minutes of the regular meeting of the Board of Supervisors of November 5, 2013 and the Minutes of the Flood Control District meeting of November 5, 2013.

County Schools

3. Approve an Intergovernmental Agreement (IGA) with the Willcox Unified School District for the Education and Technology Consortium program administration in the amount of \$40,000.
4. Approve the Cochise Community Foundation grant for education alternatives in the amount of \$8,700.

County Treasurer

5. Adopt Resolution 13-38 approving the Investment Policy of the Cochise County Treasurer in accordance with A.R.S 35-323.

Court Administration

6. Approve the purchase of courtroom audio upgrades from ExhibitOne Corporation in the amount of \$67,774.01 for the Cochise County Superior Court.

Finance

7. Approve demands and budget amendments for operating transfers.

Health & Social Services

8. Approve Amendment #1 to Intergovernmental Agreement (IGA) ADHS13-036322, STD Services, between the Arizona Department of Health Services and Cochise Health & Social Services, in the amount of \$2,200, for the period of 1/1/13 – 12/31/13.

Vice-Chairman Searle made a motion to approve items 1-8 of the Consent Agenda. Supervisor Call seconded the motion and it carried unanimously.

PUBLIC HEARING

Community Development

9. Approve a request from Valley Union High School for a waiver of building code fees, estimated amount of \$1,228, for upgrades to sports fields.

Mr. Keith Dennis, Planner II, presented this item. Mr. Dennis gave the background and said that the plans for the new upgrades included new dugouts and restrooms. He stated that staff had no recommendation.

Mr. Ortega recommended the fee be waived.

Vice-Chairman Searle asked if the Board had already approved waiver of fees for non profits.

Mr. Dennis said that he did not recall whether or not public schools were included in this category.

Mr. Hanson said that not all schools qualified as non profits, but that the Board could add them to the fee waiver exempt list.

Chairman English opened the public hearing.

Mr. Ron Aguillo, Superintendent for Valley Union School District, explained that the girls sporting facility needed to be upgraded in order to be equal to the boys' facilities and that was the reason for the building upgrades. He said that the original project was supposed to be simple, but in order to comply with building codes and procurement codes a contractor had to be hired, which meant building code fees would be added. Mr. Aguillo conveyed that although the building code fees were not expensive saving every bit of money was his main goal during these difficult economic times.

No one else chose to speak and Chairman English closed the public hearing.

Vice-Chairman Searle said he supported the waiving of fees for schools.

Supervisor Call agreed, but wanted to review current procedures and make the changes for fee waivers formal.

Mr. Ortega said a work session would be scheduled to discuss the issue and update procedures as needed.

Supervisor Call made a motion to approve a request from Valley Union High School for a waiver of building code fees, estimated amount of \$1,228 for upgrades to sports fields. Vice-Chairman Searle seconded the motion.

Chairman English called for the vote and it carried 3-0.

ACTION

County Sheriff

10. Approve two contracts for Ranch Deputy Unit equine services for reimbursement of up to \$1,000 annually per deputy for costs associated with using personally owned horses while on duty.

Lieutenant Rich Morales, Sheriff's Office, presented this item. Lt. Morales said the new ranch patrol unit had been in existence for 7-8 months and was successful because it helped deputies access some of the remote areas without damaging private property or county vehicles.

Vice-Chairman Searle moved to approve two contracts for Ranch Deputy Unit equine services for reimbursement of up to \$1,000 annually per deputy for costs associated with using personally owned horses while on duty. Supervisor Call seconded the motion.

Chairman English called for the vote and it carried 3-0.

REPORT BY MICHAEL J. ORTEGA, COUNTY ADMINISTRATOR -- RECENT AND PENDING COUNTY MATTERS

Mr. Ortega reported on the employee celebratory meetings being held countywide and the positive outcome and thanked the Board members for taking time to participate in the meetings. He gave an update on the purchase of the Three Canyons/Palominas property and said that everything was in place for closing and that the water rights issues had been resolved and cleared.
