**Board of Supervisors**

1. Approve the Minutes of the Flood Control District meeting for December 15, 2015.

Director English moved to approve item 1 on the consent agenda. Chairman Searle seconded the motion and it carried unanimously.

2. Adopt Resolution FCD 16-01 to approve a variance from elevation requirements of Cochise County Floodplain Regulations for both a substantial improvement to a non-conforming residence in Richland Ranchettes north of Sunsites, and to the residence itself, parcel 206-21-343.

Mr. Joaquin Solis, Assistant Highway & Floodplain Director, presented this item using a PowerPoint presentation. Mr. Solis gave the background, showed a map of the location and gave the reasons that the applicant had submitted in order to be granted a variance:

- The owner would like to build a 1,230 sq. ft. addition, plus a carport. In order to comply with County, State and Federal Floodplain Regulations, the addition and the existing home would be required to be elevated two feet above grade.
- The existing single family residence is 810 sq. ft., approximately 30 years old and is non-conforming (built at grade) with current floodplain regulations.
- The citizens requesting the variance state they have never had flood issues.
- The request is that they do not have to elevate either the existing home or the addition.

Mr. Solis then stated that staff had originally recommended disapproval, but upon further review staff now recommended approval of the variance.

Director English asked if the applicant would still need flood insurance.

Mr. Solis said that the applicant would still be required to obtain flood insurance. He added that current flood maps were more detailed and gave better information as to the flood areas in the County.

Chairman Searle opened the public hearing.

No one chose to speak and Chairman Searle closed the public hearing.
