Vice-Chairman Call moved to adopt Resolution 15-27 to participate in the National Association of Counties' (NACo) Stepping Up Program to reduce the number of people with mental illness in jail. Supervisor English seconded the motion.

Mr. Britt Hanson, Chief Civil Deputy County Attorney, presented this item. Mr. Hanson said that staff was excited to partake in this program because it would be address many issues with mental health inmates in a positive way.

Mark Dannels, County Sheriff, stated how much this program would help all agencies involved. He added that mental health issues were of concern due to the amount of citizens that end up in jail, instead of mental health institutions and said that this program would address the issue and ensure citizens receive the right care.

Mr. Mark Suagee, Public Defender, gave the background on the issue and noted the Justice Precinct 5 had instituted a mental health court in 2005 to help deal with these citizens and received help from Adult Probation to come up with a plan, which included two monthly hearings. He added that even with these special court hearings, many mentally ill patients were ending up in the County jail, but this program should be able to keep people out of jail that should be in treatment.

Mr. Hanson recognized all participants in this effort and added that his office received many letters of support for this program. He also said that he had coordinated training for early next year to ensure this program is a success in Cochise County.

Supervisor English said that this program had been needed for a long time and she was in full support of its implementation in Cochise County.

Vice-Chairman Call said he was excited to see this effort come together and thanked everyone who helped bring this program to Cochise County.

Chairman Searle said he agreed with the other Board members and commended all staff on their work for this program.

Chairman Searle called for the vote and it was approved 3-0.
