***CALL TO THE PUBLIC***

Chairman English opened the call to the public.

Jack Cook addressed the Board on matters of personal concern.

No one else chose to speak and Chairman English closed the call to the public.

***PRESENTATION***

Present a Fair Housing Proclamation and proclaim April 2018 as Fair Housing Month in Cochise County.

Chairman English read the proclamation and presented it to Ms. Anita Baca, Housing Director.

Ms. Baca said that she was appreciative of the Board's support and being able to provide County citizens many wonderful services.

**Board of Supervisors**

1. Approve the Minutes of the regular meeting of the Board of Supervisors of February 27, 2018.
2. Approve letter appointing Mr. Ed Gilligan, in his capacity as County Administrator, to the Arizona Counties Insurance Pool (ACIP) Board of Trustees.
3. Approve amendment to the committee appointments for members of the Board of Supervisors and executive staff for the 2017-18 Fiscal Year and approve continuing annual memberships for 2017-18, with payment of associated dues as described herein.
4. Approve revisions to the Cochise County Toilet Rebate Program regarding certain restrictions to Cochise County applicants within the Sierra Vista Sub-watershed of the San Pedro River; and deleting eligibility requirements for 501(c)3 non-profit water conservation organizations.

**Community Development**

5. Approve an addendum of an approved Intergovernmental Agreement (IGA) with the Arizona Department of Housing Office of Manufactured Housing to enforce installation standards for manufactured housing and factory-built buildings for the City of Tombstone for a five-year term, effective December 20, 2016.
6. Approve the County Engineer’s recommendation to establish a portion of Linda Vista Lane as a County Highway and schedule a public hearing for April 10, 2018.

**Finance**

7. Approve demands and budget amendments for operating transfers. Warrants Nos. 24187-24424 were issued in the amount of \$1,082,987.42.

**Housing Authority**

8. Approve a Fair Housing Proclamation to proclaim April 2018 as Fair Housing Month in Cochise County.

Supervisor Judd moved to approve items 1-8 on the consent agenda. Chairman English seconded the motion and it carried unanimously.

9. Adopt the Strategic Plan for Cochise County for 2017-2020.

Chairman English gave the background information on how the strategic plan process had occurred this time.

Supervisor Judd said it had been a great process as a new County Supervisor and would assist her in her decision making process.

Chairman English noted that the strategic plan would be used by the Board to make budget decisions.

Mr. Gilligan said it had been a positive experience and he was excited to move forward with a strategic plan that is inclusive and represents the Board's vision.

Supervisor Judd moved to adopt the Strategic Plan for Cochise County for 2017-2020. Chairman English seconded the motion.

Chairman English called for the vote and it was approved 2-0-1 (Call absent).

## **Health & Social Services**

10. Approve contract amendment: ADHS15-096693:2, Health Start Program, between the Arizona Department of Health Services, Bureau of Women's & Children's Health, and Cochise Health & Social Services to extend the contract period from July 1, 2018 through June 30, 2019.

Ms. Judy Gilligan, Prevention Services Manager, presented this item. Ms. Gilligan gave the background; stated that the purpose of this amendment would be an extension of the term period; and described specific program details.

Chairman English asked if Ms. Gilligan had any statistics or data on the success of this program.

Ms. Gilligan said she did not have that information, but would provide it for the Board.

Supervisor Judd asked about other partners for this program.

Ms. Gilligan said that there were other partners involved like First Things First and the Womens, Infant, Child (WIC) programs and between all the partners families were taken care of.

Supervisor Judd moved to Approve contract amendment: ADHS15-096693:2, Health Start Program, between the Arizona Department of Health Services, Bureau of Women's & Children's Health, and Cochise Health & Social Services to extend the contract period from July 1, 2018 through June 30, 2019. Chairman English seconded the motion.

Chairman English called for the vote and it was approved 2-0-1 (Call absent).

11. Approve amendment No. 107-18-1 to the SEAGO-Area Agency on Aging Grant for FY17-18, Contract #107-18 for Case Management and Family Caregiver Services between SEAGO and Cochise Health and Social Services which changes the new total grant award from \$180,063 to \$195,063 for the period of July 1, 2017 through June 30, 2018.

Ms. Belvet Elsouhag, County Public Fiduciary, presented this item. Ms. Elsouhag gave the background and said that this amendment was to receive additional funding to provide case workers with more hours to further assist clients.

Supervisor Judd moved to approve amendment No. 107-18-1 to the SEAGO-Area Agency on Aging Grant for FY17-18, Contract #107-18 for Case Management and Family Caregiver Services between SEAGO and Cochise Health and Social Services which changes the new total grant award from \$180,063 to \$195,063 for the period of July 1, 2017 through June 30, 2018. Chairman English seconded the motion.

Chairman English called for the vote and it was approved 2-0-1 (Call absent).

## **Housing Authority**

12. Approve the Housing Opportunities for Persons With AIDS (HOPWA) Notice of Grant Award in the amount of \$611,584 for program administration by the Housing Authority of Cochise County during the period of March 1, 2018 to February 28, 2021.

Ms. Anita Baca, Housing Director, presented this item using a PowerPoint presentation. Ms. Baca gave the background and explained how the grant award was funded; who was eligible for the grant; and other eligible activities that can be used by the person; along with referral services; and finished with the history of the grant.

Supervisor Judd moved to approve the Housing Opportunities for Persons With AIDS (HOPWA) Notice of Grant Award in the amount of \$611,584 for program administration by the Housing Authority of Cochise County during the period of March 1, 2018 to February 28, 2021. Chairman English seconded the motion.

Chairman English called for the vote and it was approved 2-0-1 (Call absent).

## **Human Resources**

13. Approve the funding for the proposed schedule of benefits and rates adopted by the Cochise Combined Trust for fiscal year 2018-2019.

Mr. Ed Gilligan, County Administrator, gave a brief overview of the process used by the Trust to come up with the benefit structure. He stated that staff was recommending that the County absorb increasing rates for administrative services within the current budget.

Ms. Julie Morales, Human Resources Director, presented this item using a PowerPoint presentation. Ms. Morales went over the plan changes. She stated that the prescription drug changes would only impact ten employees.

Mr. Gilligan noted that any modifications made were in line with nationwide models to decrease employee costs and staff always considered the impact to employees.

Supervisor Judd moved to approve the funding for the proposed schedule of benefits and rates adopted by the Cochise Combined Trust for fiscal year 2018-2019. Chairman English seconded the motion.

Chairman English called for the vote and it was approved 2-0-1 (Call absent).

14. Adopt Resolution 18-02 revising the Cochise County Compensation Policy.

Ms. Julie Morales, Human Resources Director, presented this item. Ms. Morales said this was a revision to the compensation plan to align it with the new compensation approved by the Board. She noted that the only department to give feedback had been the Sheriff's Office and they were interested on coming onboard with the Board's plan.

Supervisor Judd moved to adopt Resolution 18-02 revising the Cochise County Compensation Policy. Chairman English seconded the motion.

Chairman English called for the vote and it was approved 2-0-1 (Call absent).

### **STATE & FEDERAL LEGISLATION**

15. Discussion and possible action regarding state and federal legislative matters, including but not limited to the items in the attached County Supervisors Association Legislative Policy Committee (LPC) Agenda, the Arizona Association of Counties (AACo) Committee Agenda and the proposed State budget.

Supervisor Judd said she wanted to discuss food trucks crossing county lines and how that would be beneficial to all involved without added processes.

Chairman English said she would add this comment to the next LPC meeting.

### **REPORT BY EDWARD T. GILLIGAN COUNTY ADMINISTRATOR -- RECENT AND PENDING COUNTY MATTERS**

Mr. Gilligan gave an update on Southeast Arizona Communication Center (SEACOM). He said the building had been completed and staff was working on network connectivity, while looking at a June or July opening date. He added that the SEACOM board was also working on a recruitment for the director and budget projections for next fiscal year.

Chairman English asked Mr. Gilligan about his appointment to the Arizona Counties Insurance Pool (ACIP).

Mr. Gilligan said he had recently attended a conference to learn more about liability and risk management and was honored to be named vice-chairman of that board.
